RAGGING AWARENESS AND INFORMATION

"Ragging is any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness to any student, indulging in rowdy or undisciplined activities which cause or likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student and which has the effect of causing or generating a

sense of shame or embarrassment so as to adversely affect the psyche of a fresher or a junior student" by Supreme Court.

Ragging is a criminal offence punishable under the provisions of the Indian Penal Code. In addition to prosecution, students committing the act of ragging are also liable to being rusticated, dismissed and expelled from the college. The marks cards, character certificates and degree certificates of such students are also liable to be embossed in bold letters to the effect that he/she had indulged in ragging.

If you are ragged or subjected to any act against your will, anywhere inside or outside the college or hostel, OR if you see someone being ragged
